1.0 **GENERAL**

- 1.1 Letter of transmittal and forms for pre-qualification are attached (Section-III)
- 1.2 ALL INFORMATION CALLED FOR IN THE ENCLOSED FORMS SHOULD BE FURNISHED AGAINST THE RESPECTIVE COLUMNS IN THE FORMS. IF INFORMATION IS FURNISHED IN A SEPARATE DOCUMENT, REFERENCE TO THE SAME SHOULD BE GIVEN AGAINST RESPECTIVE COLUMNS. IF INFORMATION IS NIL, IT SHOULD ALSO BE MENTIONED AS NIL OR NO SUCH CASE. IF ANY PARTICULARS / QUERY IS NOT APPLICABLE IN CASE OF THE APPLICANT, IT SHOULD BE STATED AS NOT APPLICABLE. HOWEVER, THE APPLICANTS ARE CAUTIONED THAT NOT GIVING COMPLETE INFORMATION CALLED FOR IN THE APPLICATION FORMS OR NOT GIVING IT IN CLEAR TERMS OR MAKING ANY CHANGE IN PRESCRIBED FORMS OR DELIBERATELY SUPPRESSING THE INFORMATION MAY RESULT IN THE APPLICANT BEING SUMMARILY DISQUALIFIED. APPLICATIONS MADE BY THE TELEGRAM OR TELEX OR E-MAIL AND THOSE RECEIVED LATE WILL NOT BE ENTERTAINED.
- 1.3 The application should be typewritten. The applicants' name, dated signature and seal should appear on each page of the application.
- 1.4 Overwriting should be avoided. Correction, if any, shall be made by neatly crossing out, initialing, dating and rewriting. All pages of the pre-qualification document shall be numbered and submitted as a package with signed letter of transmittal.
- 1.5 Reference information and certificates from the respective clients certifying suitability, technical know-how or capability of the applicant should be signed by an officer not below rank of Executive Engineer/Owner. In case of works done in private sector should be supported by the TDS certificates.
- 1.6 The applicant is advised to attach any additional information, which he / she thinks is necessary to establish that the applicant is capable in all respects to successfully complete the envisaged work. He /she is however, advised not to attach superfluous information.

- 1.7 Any information furnished by the applicant found to be incorrect either immediately or at a latter date, would result in rejection of the application/cancellation of pre-qualification and shall render him liable to be debarred from tendering in future. The Vice-Chairman, DAMB through his representative reserves the right to verify the particulars furnished by the applicant independently.
- 1.8 The pre-qualification document in prescribed form duly completed and signed shall be submitted in a sealed cover. The sealed cover superscribed 'Pre-qualification document for construction of 160 nos. of Wholesale Shops at New Grain Market, Narela' shall be received by the Suptdg.Engineer-II, Delhi Agricultural Marketing Board. Documents submitted in connection with pre-qualification will be treated as official record and will not be returned.

2.0 DEFINITIONS

- In this document the following words and expressions have the meaning hereby assigned to them.
- 2.1 a) **DAMB** - means Delhi Agricultural Marketing Board
b) **APMC** - means Agricultural Produce Market Committee
- 2.2 **Employer:** means the Vice-Chairman, DAMB acting through the Suptdg. Engineer-II/ Project Engineer or any other designated Officer of DAMB, Janakpuri, Delhi
- 2.3 **Applicant:** means the individual, proprietary firm, firm in partnership, limited company – Private or Public or Corporation.
- 2.4 **Year:** means "Financial year"

3.0 METHOD OF APPLICATION

- 3.1 If the application is made by an individual, it shall be signed by the individual above his/her full written / printed name and current address.
- 1.2 If the application is made by a proprietary firm, it shall be signed by the Proprietor above his / her full written / printed name and the full name of his / her firm with its current address.

1.3 If the application is made by a firm in partnership, it shall be signed by all the Partners of the firm above their full written / printed names and current address or alternatively by a Partner holding power of attorney for the firm, in which case a certified copy of the power of attorney shall accompany the application. A certified copy of the partnership deed and current addresses of all the partners of the firm shall also accompany the application in both cases.

1.4 If the application is made by a Limited Company or a Corporation, it shall be signed by a duly authorized person holding power of attorney which shall accompany the application. The applicants should also furnish a copy of the Memorandum of articles of Association duly attested by a Public Notary.

4.0 **FINAL DECISION MAKING AUTHORITY**

The Employer reserves the right to accept or reject any or all applications without assigning any reason or incurring any liability to the applicants.

5.0 **PARTICULARS PROVISIONAL**

The particulars of the work given in Section-I are provisional. They are liable to change and must be considered only as advance information to assist the applicant.

6.0 **SITE VISIT**

The applicant is advised to visit the site of work at his own cost and examine the site of work and its surroundings to collect all information that he / she considers necessary for proper assessment of the prospective assignment.

7.0 **INITIAL CRITERIA FOR ELEGIBILITY FOR PRE-QUALIFICATION**

7.1 The applicant should have satisfactorily completed three similar works costing not less than Rs. 237 lacs or two similar works costing not less than Rs. 296 lacs or one similar work costing not less than Rs. 474 lacs during the last 7 years ending last day of the month, Nov., 2004. For this purpose, cost of work shall mean gross value of the completed work including the cost of materials supplied by the Govt. / Client but excluding those supplied free of cost. This should be certified by an officer not below the rank of Executive Engineer or equivalent. Similar work means composite building work with RCC framed structure including all services and electrical works.

- 7.2 The applicant should have average annual financial turn-over (gross) not less than Rs. 229 lacs on Civil construction works during the last three years ending 31st March, 2004. This should be supported by Balance Sheet duly audited and certified by Chartered Accountant. Year in which no turnover is shown would also be considered for working out the average.
- 7.3 The applicant should not have incurred any loss in more than two consecutive years during the last five years ending 31st March, 2004. This should be certified by the Chartered Accountant.
- 7.4 The applicant should have solvency not less than Rs. 305 lacs to be certified by his Bankers.
- 7.5 The applicant should own construction equipment required for the proper and timely execution of work. Else, he should certify that he would be able to manage the equipment by hiring etc. and submit the list of firms from whom he propose to hire.
- 7.6 The applicant should have sufficient number of Technical and Administrative employees for the proper execution of the contract. The applicant should submit a list of these employees stating clearly how these would be involved in this work and also name of person / staff who will be appointed at site.
- 7.7 The applicant's performance for each work completed in the last seven years should be certified by an officer not below the rank of Executive Engineer or equivalent and should be obtained in sealed cover on Form 'D'.

8.0 **EVALUATION CRITERIA FOR PRE-QUALIFICATION**

- 8.1 For the purpose of pre-qualification, application will be evaluated in the following manner:
- 8.1.1 The initial criteria prescribed in para 7.1 to 7.5 above in respect of experience of similar class of works completed and financial turn over etc. will first be scrutinized and the applicant's eligibility for pre-qualification for the work be determined.

8.1.2 The applicants qualifying the initial criteria as set out in para 7.1 to 7.5 above will be evaluated for following criteria by scoring method on the basis of details furnished by them

To prequalify, the applicant must secure at least 60% marks in criteria (a) &(b) i.e. Financial strength and Experience in works of similar nature. 50% marks in each of the other criteria and seventy percent marks in aggregates.

The Vice-Chairman, DAMB, however, reserves the right to restrict the list of pre-qualified contractors to any number deemed suitable by him.

8.2 Even though an applicant may satisfy the above requirements, he would be liable to disqualification if he has:

- (a) made misleading or false representation or deliberately suppressed the information in the forms, statements and enclosures required in the pre-qualification document.
- (b) record of poor performance such as abandoning work, not properly completing the contract or financial failures / weaknesses etc.

9.0 **FINANCIAL INFORMATION**

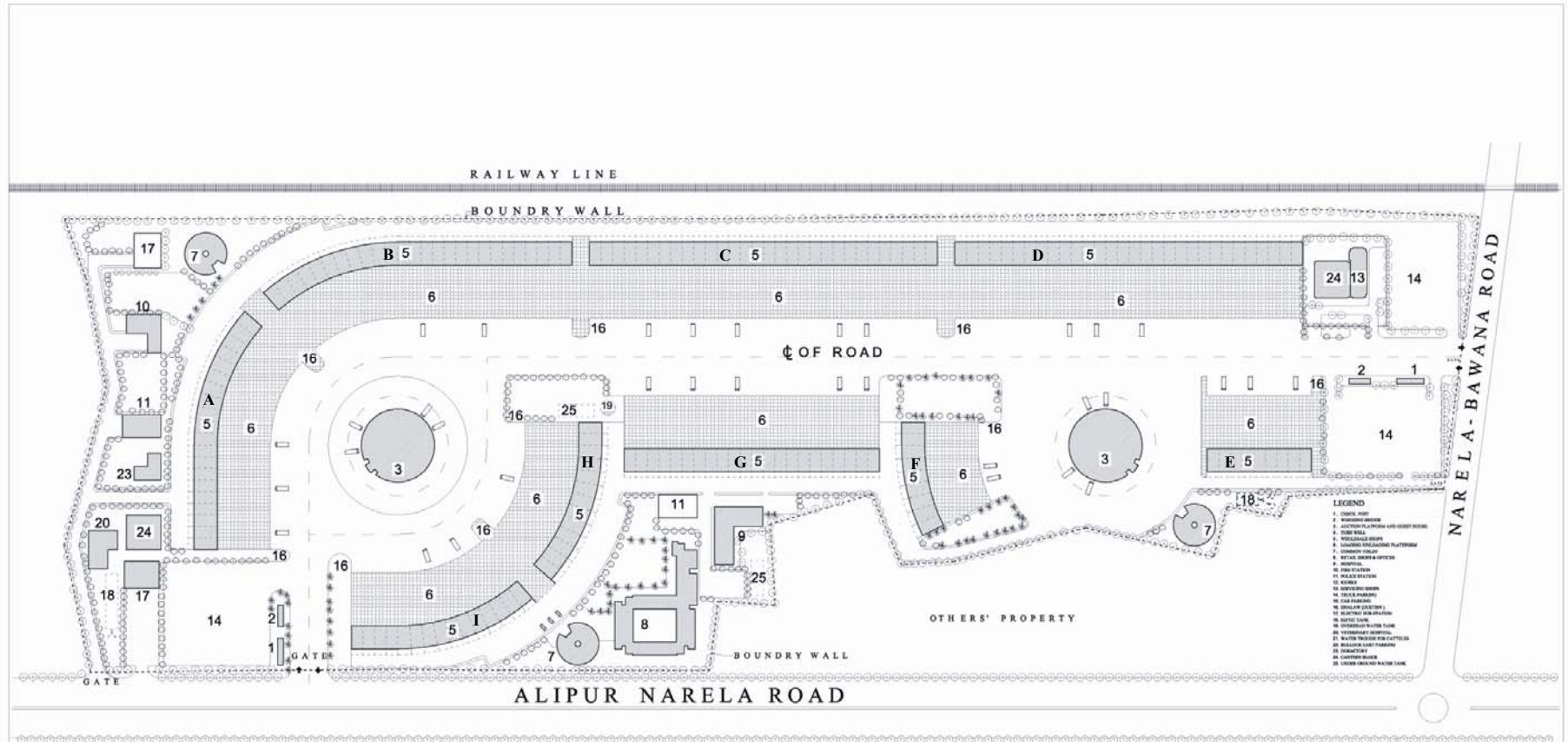
